Monday, August 28, 2023 – 6:00 PM

Approval of the Agenda: Motion by Campbell, 2nd by Wendel approving the agenda, all yes, motion carried.

Department Reports:

- e. Motion by Wendel, 2nd by Campbell approving DSG quote for \$4,422.36 for 2nd Avenue and 4th Street sewer line, all yes, motion carried. It was noted that Cooksley work looks good.
